

Cookie Policy

I. Introduction

This Cookie Policy describes how we at Eton Pharmaceuticals (also referred to as “Eton,” “us,” or “we”) use cookies and similar technologies to collect and use data as part of our services as defined in our [Privacy Policy](#). This Policy applies to any Eton product or service that links to this policy or incorporates it by reference.

By visiting the website managed by Eton, including www.etonpharma.com (“Site”), You consent to the use of cookies in accordance with this Cookie Policy. A pop-up asking for Your consent to this Policy was visible on Your first visit to our Site. By continuing to visit or use our services, You are agreeing to the use of cookies and similar technologies for the purposes described in this Policy. You may withdraw Your consent at any time by following the instructions below.

This Cookie Policy does not apply to, and we are not responsible for, the privacy practices of third-party websites which may be linked to our Site.

Please note that Eton reserves the right to revise this Cookie Policy at any time at our sole discretion. Therefore, You are urged to review the Cookie Policy each time You access this Site to ensure that You are familiar with the most current version. If we modify the Cookie Policy in a material way, we will post a notice on the Site to let You know that the Policy has been so modified. Use of this Site following such modification (or following any nonmaterial change) constitutes Your acceptance of the revised Cookie Policy then in effect.

II. What Is a Cookie?

Cookies are small bits of information that are stored by Your computer's web browser and are classified as identifying files sent to a computer by a web server. Websites read these uniquely identifying files for future access and enable servers to associate computers to user profiles. HTTP logging consists of transaction files between a web client and server. The other tracking technologies work similarly to cookies and place small data files on Your devices or monitor Your website activity to enable us to collect information about how You use our Sites. This allows our Sites to recognize Your device from those of other users of the Sites.

Cookies can be useful because they allow a website to recognize a user’s device. Cookies allow users to navigate between pages efficiently, remember preferences, and generally improve the user experience for You. They can also be used to tailor advertising to Your interests through tracking Your browsing across websites.

III. How Do Our Sites Use Cookies and Other Similar Technologies?

As You navigate through this Site, we may automatically collect (that is, gather without You actively providing the information) certain information using various technologies and means, such as Internet Protocol (IP) addresses, cookies, Internet tags, web beacons, and navigational data collection. For example, Your Internet browser automatically transmits to this Site some of this unidentifiable information, such as the URL of the website You just came from, the IP address, and the browser version Your computer is currently using. This Site may also collect information from Your computer through cookies, HTTP Logging, or other technological means.

Eton uses cookies and other similar technologies to identify You and Your interests, to remember Your preferences, and to track Your use of our Sites. We also use cookies and other similar technologies to control access to certain content on our Sites, protect the Sites, and to process any requests that You may make.

Depending on the Site, we use the following types of cookies:

Persistent cookies. We use persistent cookies to improve Your experience of using the Sites. This includes recording Your acceptance of our Cookie Policy to remove the cookie message, which first appears when You use the Sites.

Session cookies. Session cookies are temporary and deleted from Your machine when Your web browser closes. We use Session cookies to help us track Internet usage.

To administer our Sites and for research purposes, Eton may also contract with third-party service providers to track and analyze statistical usage and volume information from our Site users. These third-party service providers use persistent cookies to help us improve the user experience, manage our Site content, and analyze how users navigate and utilize the Sites. For example, Google Analytics (<http://www.google.com/analytics>) uses cookies to collect information about Site visitors in order to provide analytics services based on a user's visits to sites across the Internet and across other mobile applications. Some web browsers may transmit "do-not-track" signals to the websites with which the user communicates. Because of differences in how web browsers incorporate and activate this feature, it is not always clear whether users intend for these signals to be transmitted, or whether they even are aware of them. Because there currently is no industry standard concerning what, if anything, websites should do when they receive such signals, Eton currently does not take action in response to these signals. If and when a final standard is established and accepted, we will reassess how to respond to these signals.
